IFSC ELECTIONS 2021

1. SCHEDULE

The next IFSC Elections are scheduled to take place on **Saturday 24th April 2021** at the XVII IFSC General Assembly of Paris, France.

2. PROCEDURE AND REQUIREMENTS

As per Article 14 of the IFSC Statute, IFSC Member Federations wishing to nominate one or more candidates for any one of the IFSC positions elected by the General Assembly, shall complete the relevant form and return it to the IFSC Office (office@ifsc-climbing.org) by and no later than **Sunday 24th January 2021, 23:59 UTC+1**. Late and incomplete submissions will not be accepted.

Nominating Member Federations are reminded that:

- All candidates for election must be nominated by the IFSC Member of the country in which they hold citizenship;
- A candidate shall not be nominated for more than one position
- IFSC Executive Board members are elected in a personal capacity, and not as representative of any Member Federation and are to act independently from these.

Each position has its own Nomination Form: these are available for download on the [IFSC website](#). Candidate Nominations shall be proposed and signed by the President or Secretary General of the Member Federation nominating the candidate.

To complete the nomination process, both the Nominating Federation and the Candidate shall fill in the appropriate Nomination Form in all relevant parts.

In addition, all submissions must be accompanied by the following documents:

- Candidate's CV;
- A letter of motivation from the Candidate;
- A letter of recommendation from the Nominating Member Federation;
- A valid copy of the Candidate's passport.
