I. Obligations of Team Officials

By applying for an International Team Official Licence, I acknowledge the rules of IFSC and commit myself to act according to these rules.

> *In particular:*

- I understand and abide by the regulations and rules of the sport and observe the principles of good sportsmanship;
- I acknowledge and accept that I cannot hold a Team Officials accreditation together with a Media Accreditation; I understand that failure to comply with the above may result in the withdrawal of both accreditations at the discretion of the Technical Delegate;
- I will accept, subject to the official appeal procedure, the decisions of the official judges without question or protestation and exercise self-restraint at all times;
- I will treat other Team officials, Athletes, Officials and others involved in the practice of the sport with full and due respect at all times, both during and outside a competition;
- I will not be involved in betting in respect of IFSC competitions and will comply with the IFSC Code of Conduct on Sports Betting Integrity.

> *In connection with anti-doping:*

I recognise that as an *Athlete Support Personnel*, I am subject to the jurisdiction of IFSC, or of any *National Federation*, or of any member or affiliate organization of any *National Federation* (including any clubs, teams, associations or leagues), for purposes of anti-doping.

In addition:

- I expressly acknowledge the right of WADA and any other anti-doping organisation to perform out-of-competition tests on Athletes I may be in charge of on behalf of the IFSC;
- I expressly acknowledge the right of IFSC and WADA to start or to join as a party in disciplinary proceedings in connection with any disciplinary offence (including involvement in doping cases) against me.
- I will refrain from facilitating, providing and encouraging others to use prohibited substances and methods described in the IFSC Anti-Doping rules and WADA Code as well as transporting the above substances.

> *In connection with Body Mass Index tests*

- I understand that IFSC may, from time to time, perform Body Mass Index tests on athletes I may be in charge of;
- I understand that any absence from, or refusal to perform, such test may result in the disqualification of the athletes I may be in charge of, or any other sanction as may be provided for in the rules of the IFSC.

> *In connection with image use and IFSC communication initiatives*

As a participant in an event authorized or recognized by the IFSC, I hereby declare confirm my agreement with the following:



- I agree to be filmed, photographed or otherwise recorded while performing at IFSC competition and more generally in the context of the authorized or recognized IFSC events (e.g. interviews) and I grant the IFSC a royalty-free licence to use such photographs or audio-visual recordings without limitation of time or territory, for the promotion of Sport Climbing and to authorize third parties (in particular its broadcast partners, IFSC sponsors and Olympic bodies) to use such photographs or audio-visual recordings in their coverage of the IFSC events and editorial use, through any media (known or to be known);

- I agree to support, when possible, the IFSC in the promotion of its competitions and, more globally, of Sport Climbing as well as other networking opportunities (e.g. co-commentating, attendance to workshop, etc.).

> In connection with the prevention of the manipulation of competitions

As a member of the above-mentioned National Federation and/or a participant in an event authorized or recognized by my National Federation and/or the IFSC, I hereby declare as follows:

I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the Olympic Movement Code on the Prevention of the Manipulation of Competitions, and IFSC Rules in Competition Integrity as published on the IOC and IFSC website.

II. Obligations of IFSC Member Association

A Member Association whose Team Official applies for an International Licence undertakes:

- to inform the IFSC immediately of any change of the Team Official details given above;
- to inform the IFSC immediately of any disciplinary proceedings against the Team Official;
- to start on request of IFSC without delay disciplinary proceedings against any Team Official who has been involved in any doping case or illegal betting case and to keep the IFSC fully informed about the progress of any such proceedings.



IMPORTANT NOTICE

- All Team Officials wishing to perform their duty in International Climbing competitions must be in possession of an International Licence issued by the IFSC.
- Those Team Official for whom their belonging Federations have not applied for an International Licences and who are not registered for the relevant competition, will NOT be allowed to perform the following duties in IFSC approved events:
 - Submit appeals;
 - Access isolation zone, Team Official zone and other restricted areas of the Field of Play.In addition, and in case of, no free access to the competition venue will be granted to non-registered Team Officials.
- Team Officials will be requested to inform the IFSC of their exact roles, such as Head of Delegation (Team Manager), Physio/Medics, Coaches.
- Validity of each licence expires at the end of the current calendar year.
- Each year, before the first competition of the season (or before the first competition of the season in which their Team Officials intend to perform their duty), every Federation shall apply for new licences or for renewal of existing ones, all in written and using this form. Forms without the seal and the signature of the applying Federation and of the Team Official shall not be taken into consideration.

Therefore,

A copy of the complete licence form (all pages), duly sealed and undersigned by the Federation's officer in charge and the competitor and reporting the date when it was signed, shall be uploaded to the IFSC results system.

Each Form is to be used for ONE Competitor only.

Licence will be considered valid only when its status on the IFSC results system appears as CONFIRMED.

2020 Annual Licence fee: 35 €/ Team Official, for both new and renewed licences. These fees are to be paid upon receiving the relevant invoice, at the end of the season.
No registration fees to the competitions will be applied.
